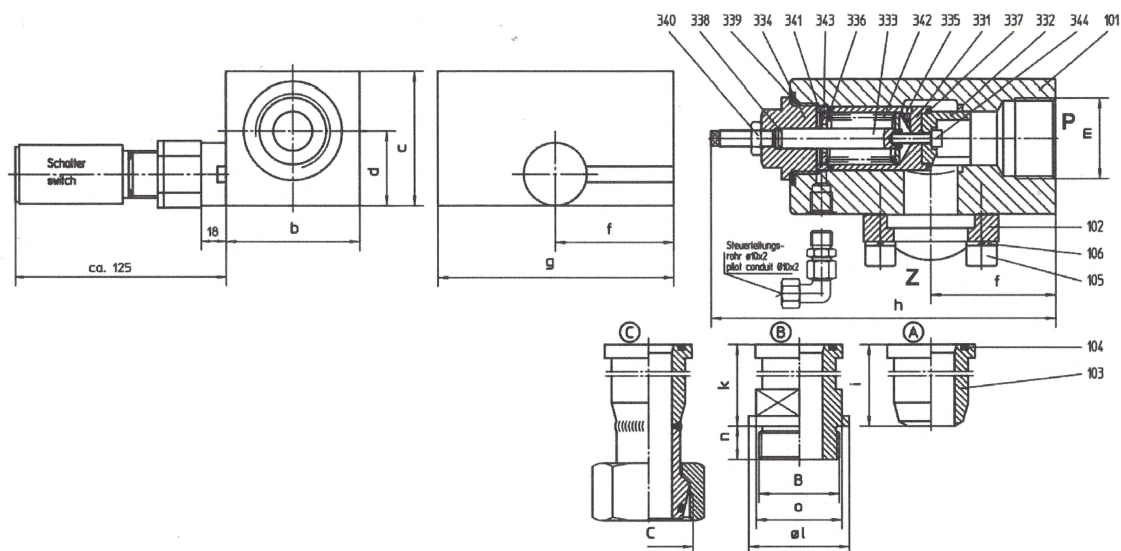
1. Scope of application:

Type designation: LRS-EN 50
Product type: rupture valve
Field of application: To be used for elevators in accordance with the directive 2014/33/EU
Flow range: 280 – 1150 [l/min]
Pressure range: 10 – 80 [bar]
Viscosity range: 20 – 450 [mm²/s]
Temperature range: 0 – 65 [°C]

2. Remarks:

- 2.1. Each product must be accompanied by the instructions which are necessary for its operation and installation.
- 2.2. Rupture valves having a range of use and needing an adjustment according to the special conditions of the lift in which they are installed, shall be provided with means to prevent unauthorized readjustment. This can be done for instance by sealing.
- The correct adjustment and the means to prevent unauthorized re-adjustment are within the responsibility of the manufacturer of the rupture valve and the installer; the latter following the installation and adjustment instructions of the manufacturer.
- 2.3. Each product must bear a distinct indication of the manufacturer or importer and a type designation, so that the identity of the tested sample might be determined with the standard product launched on the market.
- 2.4. The EU type-examination certificate may only be used in connection with the pertinent Annex.
- 2.5. ÉMI-TÜV must immediately be notified if there are any changes in the products compared to the certified version.
- 2.6. The EU type-examination certificate may lose its validity if the requirements are modified.
